

Since this paper there have been numerous enhancements to this software.

The CDC in the US have a disease reporting requirement for all States to keep track of patients with infectious reportable diseases including SARS.

Each State is then responsible for ensuring that they meet this CDC requirement.

All the hospitals and labs have access to this database. It allows for cluster tracking, and other useful analysis.

It consists of a simple oracle database with a web based front end with analysis tools.

The state of New Jersey in the US have a system that they developed for this purpose as part of their CDC reporting requirements called HAN (Health Alert Network).

It was developed by the New Jersey Institute of Technology.

I have spoken to the developers and they are willing to help set this up in Hong Kong

and adapt their database system for use in Hong Kong.

DIRECT POINT OF CONTACT

This system would be utterly trivial in cost but the benefits could be enormous

in the future, the present lack of a tracking $\,$ mechanism in Hong Kong is a significant

problem which has yet to be addressed.

I would be willing to donate pro-bono significant amounts of my time as a civic duty to help get this up and running here since it would be of clear and quantifiable benefit to Hong Kong.

If the committee so wishes it can consider this as part of their recommendations or if

the committee thinks it appropriate I would be willing to submit a formal written proposal.
